#### **What is the Junior League of Greensboro?**

The Junior League of Greensboro is an organization of women committed to promoting voluntarism, developing the potential of women and improving the community through the effective action and leadership of trained volunteers. Our purpose is exclusively educational and charitable.

Founded in 1926, the current membership of the Junior League of Greensboro is comprised of approximately 900 Active and Sustaining members. The Junior League of Greensboro reaches out to women of all races, religions, and national origins who demonstrate an interest in and a commitment to voluntarism.

#### **Who is a Junior League member?**

A Junior League of Greensboro member is a woman who wants to learn how to build a better community. She is a woman who wants to be an effective volunteer, leader, mentor, and team member. She seeks out other women to work together to reach common goals. A Junior League of Greensboro member values the opportunity to make lasting connections and lasting change in her community.

#### **Who is a Provisional Junior League Member?**

- A prospective member must have an interest in voluntarism, a commitment to community service and an interest in developing her potential for voluntary community participation.

- Prospective members must have reached their 21<sup>st</sup> birthday by January 1st of the year in which she applies for membership.
- The resident prospective member must be residing in Greensboro or the surrounding area at the time of her application for membership.
- A prospective member who is in college at the time of application shall be considered a resident if her parents or guardians are residing in the area.
- A non-resident prospective member may apply. She must have resided in the area for two (2) consecutive years and not have lived away from the area for more than five (5) years at the time of her application, or resided in the area for a total of ten (10) years and not have lived away from the area for more than five (5) years at the time of her application.

## Provisional Membership Agreement

Below is a list of Provisional Member requirements for the Junior League of Greensboro's 2017-2018 Provisional class. Please read through this list before initialing each line and signing below to indicate your acceptance.

\_\_\_\_\_ I agree to pay annual dues of **\$136** and **\$140** for meeting expenses for a total of **\$276**. **The payment is due by the admissions deadline of Friday, August 11, 2017**. This payment is non-refundable.

\_\_\_\_\_ I agree to attend the **mandatory Provisional Orientation on Saturday, August 26th, 2017**.

\_\_\_\_\_ I agree to the following:

- \* During my Provisional Course, I agree to work a minimum of **4 shifts (6 maximum)** at the Junior League of Greensboro thrift shop (the Bargain Box).
- \* Upon completion of my Provisional Course (i.e. upon becoming Active) I agree to donate \$50.00 worth of salable merchandise to the Bargain Box) twice a year.
- \* During my Provisional Course, I agree to work **1 shift** in an external placement/community program placement.
- \* During my Provisional Course, I agree to participate in one JLG Event (Touch a Truck or Women's Leadership Summit).

\_\_\_\_\_ I agree to attend General Membership meetings. General Membership Meetings are typically held the first Monday of each month. Provisionals will be held to the same GMM requirements as Active members (unlimited excused absences and 2 unexcused absences for any reason).

\_\_\_\_\_ I agree to attend Provisional Course Meetings and to participate in the **Provisional Class Project** (the Provisional Class Project is TBD). I understand I will be expected to make-up any Course or Project Meetings that I am unable to attend, not to exceed two meetings. Missed shifts can be made up at the Bargain Box.

\_\_\_\_\_ I understand that I will be voted into Provisional Membership for the 2017-2018 League year by the Board of Directors of Junior League of Greensboro, North Carolina, Inc., upon receipt of this completed application packet and membership dues.

\_\_\_\_\_ I understand that the Provisional Course is scheduled from August – May, and that in order to be eligible for Active membership, I must fulfill the requirements listed above by May 7, 2018.
